# Request for Decision – 2023 Budget Planning Timeline

A preliminary budget schedule with suggested timelines and activities was provided for Council's review and consideration. The annual budget for the Town of Blackfalds consists of the 2023 Operating Budget with a three-year forecast, and a 2023 Capital Budget with a ten-year Capital Plan. Both Budgets will follow a process consisting of Planning, Development, Endorsement, Approval and Communication. Also, included in the budget timeline is the Public Engagement component of budgeting.

Council unanimously accepted the recommendations of Administration to approve the 2023 Budget Timeline as amended.
