Business

CAO Report

Acting CAO de Bresser reviewed the various organizational operations and activities during the month of July.

Request for Decision – Quarterly Finance Report

Acting CAO de Bresser presented the Quarterly Financial Report, which consists of the Operating Statement of Revenue & Expenditures, Divisional Variance Analysis, Capital Projects Update, and Council Expenditure Report for the six-month period ending June 30, 2021. Council accepted these reports as information.

Request for Decision – Elected Officials Development Opportunities Policy

The Elected Officials Professional Development Policy is used to outline the parameters and financial considerations for Council to attend professional development sessions which support their role. Council had further revisions and requested this item be referred back to Administration for further information.

Request for Decision – Congratulatory Letter

On July 8, 2021, MLA Ron Orr was appointed the Minister of Culture. As the provincial representative for the Lacombe-Ponoka constituency, which includes Blackfalds, a letter of congratulations for this appointment was drafted and will be sent out to him.

Costs of RCMP Unionization

AUMA has drafted a letter for municipalities to advocate that the federal government be responsible for RCMP retroactive pay increases, as some municipalities will struggle to absorb significant increases to their policing costs.
