Operating Statements, Variance Analysis & Capital Project Report – March 31, 2020

Blackfalds Girl Guides - Rental Request

Proposed Subdivision S-01-20-1 & 2 Condo Plan 982 0094

Director of Infrastructure and Property Services, Weran, presented a proposal to subdivide a section of land at S-01-20-1, Lots 1 & 2 – Condo Plan 982 0094. Accelerated Surveys Ltd, on behalf of the landowners are seeking permission to subdivide the property into a shared parcel with the same lot lines as a duplex. Notifications were sent out with no objections to date.

Deputy Mayor Olfert moved that Council move to approve the Subdivision of Lots 1 & 2, Plan 982 0094 subject to the following:

- 1. That pursuant to Section 85 of the Land Titles Act, the subdivision, as shown on the Tentative Plan of Subdivision, is registered by Plan of Survey.
- 2. That pursuant to Section 654(1)(d) of the Municipal Government Act, all outstanding property taxes are to be paid, or some other arrangement, satisfactory to the Town of Blackfalds, for payment thereof be made.
- 3. That pursuant to Section 655(1) of the Municipal Government Act, that the owner/developer register utility easement right of way including any drainage easements as per the requirements of the Town of Blackfalds and/or utility companies concurrent with or prior to registering the subdivisions Plan of Survey.
- 4. That any subdivision takes in consideration the conditions set by the Utility companies.
- 5. That proposed Lot 1 and Lot 2 maintain separate accesses via Womacks Road.
- 6. The developer enters into a Party Wall Agreement, ensuring it is registered onto the Certificates of Titles for proposed Lot 1 and Lot 2, for the adjoining common boundary line existing between Lot 1 and Lot 2. The preparation and registration of the Party Wall Agreement are at the developer's expense.
- 7. Surveyor must co-ordinate with the Town that the proposed subdivision is in accordance with all Development Permits for this site.
