Bylaw 1351.26 – 5401 Blackfalds Industrial Way Redistricting

Council held a Public Hearing regarding the proposed redistricting of a portion of 5401 Blackfalds Industrial Way from Industrial Heavy District (I-2) to Parks and Recreation District (PR); no members of the public spoke.
