The Town of Blackfalds Council held its Regular Council Meeting on Tuesday, May 26, 2026. Below are the key decisions and actions from the meeting.

#### CONSENT AGENDA

Council adopted the Consent Agenda for May 26, 2026, including approval of previous meeting minutes, administrative reports, and other informational items.

#### BUSINESS ITEMS

##### Aspen Lakes West Phase 2A Redistricting – Bylaw 1358.26

Council gave First Reading to Bylaw 1358.26 to redistrict lands in Aspen Lakes West Phase 2A from Urban Reserve to residential districts and set a Public Hearing for June 23, 2026.

##### Subdivision – 4409 South Street

Council approved the subdivision of the property into three lots, subject to standard conditions.

##### Animal Control Bylaw – Bylaw 1359.26

Council rescinded a previous Animal Control Bylaw and gave First, Second, and Third Reading to Bylaw 1359.26, including amendments related to offences, penalties, and dangerous dog provisions.

##### Community Centre Emergency Generator

Council approved additional funding from Capital Reserve and awarded a \$266,709.24 contract to Timcon Construction (1988) Ltd. for installation of an emergency generator.
